The Washington State Department of Transportation (WSDOT) invites residents of the Montlake community to hear updates about the nomination of the Montlake neighborhood to the National Register of Historic Places (NRHP).

WSDOT's team of architectural historians is busily compiling information to finish the draft Montlake Historic District NRHP nomination. The team conducted a survey and inventory of 50 blocks (approximately 1,200 buildings) between the Montlake Cut to the north and Interlaken to the south, 15th Avenue East to the west and the Arboretum to the east.

In the upcoming weeks, interested Montlake residents will be able to review and comment on the draft NRHP nomination. At this public meeting, attendees can learn more about the review process and ask key staff questions. Information regarding the report will be provided on the 520 history website listed below.

WSDOT is conducting this work as a mitigation commitment for the SR 520, I-5 to Medina: Bridge Replacement and HOV Project, as requested by the Montlake Community Club. WSDOT is conducting this work in coordination with the Washington State Department of Archaeology and Historic Preservation, historic preservation specialists, and the Montlake Community Club.
